Monthly Meeting Minutes

October 14, 2020

The Ocean Highway and Port Authority of Nassau County held its Monthly Meeting on Wednesday, October 14, 2020 at the County Commissioners Chambers at the James S. Page Government Complex, 96153 Nassau Place, Yulee, Florida 32097.

The meeting was called to order at 6:11 PM by Chairman Fullwood.

The invocation was given and the Pledge of Allegiance was led by Commissioner Cole. Roll call was conducted by Mrs. Barbara Amergian. All Commissioners were present. Also in attendance were Jeb Branham, Port Attorney; Pierre LaPorte, Port Accountant. Absent was Chris Ragucci, Port Director/Operator.

Chairman Fullwood recognized City Commissioner Chip Ross, 210 N 3rd Street, Fernandina Beach, FL. Mr. Ross wanted to know what the Commission planned to do about the flooding at the Port during King Tides. He also inquired as to whether the Ocean Highway & Port Authority would be televising their monthly meetings. He had comments regarding the agenda item that pertain to the Broome Street property but would wait until the agenda item was addressed in the meeting. The Commissioners would take under advisement dealing with tidal flooding at the Port when Mr. Ragucci was available to give input.

Commissioner Hanna made the motion to accept the minutes of the September 9, 2020 monthly meeting and the September 24th special meeting. The motion passed unanimously.

Port Accountant Pierre LaPorte presented the September 2020 financials to the Board; with nothing out of the ordinary to report. He informed the Board that the auditors would be doing the fiscal year audit the week of November 9, 2020.

Port Attorney Jeb Branham presented his monthly report to the Board. The City of Fernandina Beach will be filing the PILOT payment lawsuit against OHPA soon. The Channel Re-Alignment issue has taken "a backseat" and will be dealt with at some point. Attorney Branham and Chairman Fullwood attended a confidential mediation on October 9, 2020 with TranSystems; Mr. Branham is optimistic the financial matter will be resolved. The City of Fernandina Beach has approached Representative Cord Byrd and Senator Aaron Bean about introducing a Bill to amend OHPA's Legislative Charter; specifically asking for an amendment to Section 12 that states OHPA does not have to get permits from any local government and the amends proposed would require OHPA to get permitting from either the City or the County, depending on who would have jurisdiction over the permit and that OHPA would have to pay building fees, impact fees, and specifically comply with zoning regulations as well. Attorney Branham reported that he had met with Representative Byrd to discuss ways to resolve these issues.

New Business Items regarding the Customs House Preservation and the Building Permits were discussed at this point in conjunction with Attorney Branham report. Mr. Branham read two resolutions being presented to the Board for approval. He stated that OHPA is committed to preserving the Customs House and if that is not possible, then the Custom House will be offered to the City of Fernandina Beach.

Mr. Branham pointed out to the Board that by adopting these resolutions, this would show good faith on behalf OHPA to Representative Byrd and Senator Bean.

Commissioner Hanna made the motion to adopt Resolution 2020-R07. With no further discussion, the motion passed unanimously.

Commissioner Cole made the motion to adopt Resolution 2020-R08. With no further discussion, the motion passed unanimously.

Port Director/Operator Chris Ragucci was not in attendance at the meeting. There is no tonnage report.

RESOLUTION NO. 2020-R04. A RESOLUTION OF THE OCEAN HIGHWAY AND PORT AUTHORITY OF NASSAU COUNTY, FLORIDA. ADOPTING ITS BUDGET FOR FISCAL YEAR 2020-21; PROVIDING FORAN EFFECTIVE DATE.

The agenda item Proposed Acquisition of the Broome St. Property Adjacent to and Contiguous with the Port. Seeking Authority for OHPA to Execute a PTGA (Grant Agreement) with FDOT to Finance Improvements thereon, on a contingent Basis was tabled due to Mr. Ragucci's absence.

Chairman Fullwood and the rest of the Commissioners thanked him for all of his dedication to the Ocean Highway & Port Authority and for his time as Chairman. A donation was made in his honor to the charity of his choice in lieu of a plaque.

Chairman Fullwood informed the Board that he had received a call from the Florida Ports Council and the Council would like the Board to make a decision in the next few months regarding hiring a Port Director. Chairman Fullwood will attend the December meeting and the Florida Ports Council would like to have a new Port Director for the Port of Fernandina in place for March of 2021. Mrs. Amergian gave the Board the latest rendition for the Nassau Tradeplex sign done by Design It Wraps and Graphics. Quote information will be presented at the next meeting.

With no further business to come before the Board, the meeting was adjourned at 7:11 PM.

Below are updates on the near-term legal issues:

1. Fernandina Beach has now filed suit over the PILOT payments dispute. I will file a motion to dismiss the complaint shortly.

2. The interlocal agreement for the city to assume financial liability associated with the westward channel realignment has taken a back seat to higher priority matters between the city and OHPA. It will likely remain this way for the near term.

3. TranSystems, OHPA, and WTF mediated the lawsuit filed by TranSystems on October 9. The parties have not reached a settlement agreement, but the mediator has not yet declared an impasse. If the mediator declares an impasse, then TranSystems will be free to resume its litigation against OHPA and WTF.

4. The City of Fernandina Beach has approached Representative Cord Byrd and Senator Aaron Bean about amending OHPA's legislative charter to remove the authority the legislature gave to OHPA to construct and regulate buildings on its own and to make OHPA subject to city regulation. The city initially made three complaints in connection with its legislative request: a) what the city sees as discrepancies between its Comprehensive Plan and OHPA's Strategic Master Plan; b) the preservation of the customs house; and 3) port expansion. The city appears to have added the pending PILOT payment dispute into their three previous complaint. On Friday, October 30, I, Commissioner Franklin, Tammi Bach, Dale Martin, Len Kreger, Aaron Bean, Cord Byrd, and Buddy Jacobs met. We explored near term solutions so that a bill does not have to move forward during this legislative session. Although we did not reach any firm agreements, I believe we made some positive progress. 


